Terms of Service

Overview

By subscribing to BankersHub® Passport Membership, you agree to the following Terms of Service contained in this agreement.

BankersHub® and BankersHub® Passport are owned and operated by Bstuff LLC (hereinafter referred to as Bstuff, BankersHub®, we, or Company), an LLC in good standing within the state of Wisconsin, with corporate headquarters at 722 Milky Way, Madison, WI 53718.

Please carefully read, review and be sure you understand our Membership Conditions, as your purchase and use of any events, playbacks, learning certifications or other Bstuff products available herein identifies that you agree to the following conditions and that you agree to be bound by these terms and conditions accordingly.

When you subscribe to BankersHub® Passport Membership we hereby grant to you a non-exclusive limited, non-transferable license to 1 (one) registration for each event (defined below) hosted by BankersHub®, plus playback links and/or files of that event, for a period not less than 12 (twelve) months, and/or as stipulated a formal promotion offered by Bstuff LLC. A standard Membership extends from the beginning of the month in which it is purchased through the end of the month one year hence.

- Example, a Passport Membership purchased on March 25, 2015 will give the Member access to playbacks starting on March 1, 2015 and full access to live events and playbacks through March 31, 2016.

Prohibited uses include, but are not limited to, the following:

1. Distribution of handouts, playback files, links and other proprietary materials associated with events to any individuals not employed by the organization, institution, or individual registered as the primary purchaser of BankersHub® Passport.
2. Material alteration, editing, deletion or any other change to handouts, playbacks and other materials associated with events. Event materials are the exclusive property of Bstuff LLC and the presenter. Changes may only be made at the express written consent of Bstuff LLC.
3. Sale or rebroadcast of handouts, playbacks, or materials associated with events. BankersHub® Passport Members are permitted to broadcast or post playback files and/or links on internal websites as long as access to files and materials is strictly controlled and limited only to employees of the organization, institution or individual registered as the primary purchaser of BankersHub® Passport.

Any new features, enhancements, tools or resources that augment the current Membership, shall be subject to the Terms of Use. Continued use of the Membership after any such change shall constitute your consent to such changes. Violation of any of the terms below will result in the termination of your account.

Events Defined and Included in BankersHub® Passport Membership Fee

- “Webinars”: 60 to 90 minute standalone events
- “Two Part Series”: A series of 2 webinars on the same or related topics.
- “Bootcamp”: A 3-part series of webinars on the same or related topics.

- “360”: A full-day series of 5 to 7 webinars on the same or related topics.
- “Webcast”: A webinar offered at no cost to the general public which may or may not be sponsored by a corporate or other entity.

General Terms of Membership

- You must provide a full legal name as primary point of contact along with a valid email address, phone number, and any other information required by Bstuff LLC in order to complete the Passport Membership registration process.
- Unless stated otherwise, it is assumed under this Passport Membership that the Corporation, Institution or Formal Entity identified in the purchase has the ultimate ownership of the Membership and that the Membership will not follow the purchaser upon separation from employment. If the primary contact is replaced for any reason, a formal statement is required by a designated representative of the Corporation, Institution or Formal Entity of that fact along with designation of a new contact for assignment.
- Technical support is provided at no charge to paying accounts.
- Bstuff LLC may, from time to time, offer additional benefits, discounts or privileges to Passport Members. These additional offers are separate from this Agreement and may be cancelled, extended or modified at any time and without prior notice to Members.
- You may not sub-license, assign, or transfer this license to any other legal corporate entity or organization without prior written consent from Bstuff LLC.
- You understand and acknowledge that the technical processing and transmission of events, playbacks, presentations and other materials, may be transferred unencrypted and involve transmissions over various networks and changes to conform and adapt to technical requirements of connecting networks or devices.
- BankersHub® is not responsible for emails, notifications, advisories, etc. sent to Passport Members that are not received by the Member for any reason, due to, but not limited to, firewalls, server restrictions, anti-spam software, etc. To prevent that from occurring, Passport Members are encouraged to set up BankersHub® as a ‘white label’ company and email provider.
- Though highly unlikely, Bstuff LLC reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, the event offerings or any part thereof, without advanced notice. You agree that Bstuff LLC shall not be liable to you or to any third party for any modification, suspension or discontinuance of the offering. Any Membership fees paid by the customer at the time of cancellation shall be refunded upon termination or discontinuance based on length of time since initial purchase or renewal. Members would still be able to retain and use playback files in accordance with this agreement, however.
 - Within 30 days of purchase – Full refund of fees
 - 31-60 days of purchase – 75% refund
 - 61-90 days of purchase – 50% refund
 - 91-120 days of purchase – 25% refund
 - 121+ days of purchase – no refund

Renewals

BankersHub® will contact the Passport Member approximately 60 days in advance of annual renewal and will attempt to notify the Passport Member of the renewal up to time of expiration. If the Membership is not renewed by midnight on the last day of the month in which the Membership expires, access to the INXPO environment and future events will cease. Any Membership after expiration may still be renewed and reactivated at the Membership rate currently advertised. Reinstated Memberships may not have access to events or playbacks that transpired

during the period of after expiration and before renewal, however. BankersHub and Bstuff LLC cannot be responsible for emails or communications that do not reach the Member for any reason including, but not limited to, firewalls, servers, anti-spam restrictions, etc.

Cancellation and Termination

You are solely responsible for properly canceling your account. To cancel your account, send an email to service@BankersHub.com. **Upon your cancellation, no credits are given for unused months unused.**

Bstuff LLC, in its sole discretion, has the right to suspend or terminate any Member's account and refuse any and all current or future use of the services at any time, as a result of abuse or violation of the service or terms of agreement. Such termination of the Membership will result in the deactivation or deletion of your Membership or your access to events and services, and the forfeiture and relinquishment of all playbacks and event materials. In the event of Service termination or cancellation, provisions of these Terms of Service related to the following shall survive: Indemnity, Warranties and Limitation of Liability. For the protection and safety of all of our customers, Bstuff LLC reserves the right to refuse service to anyone for any reason at any time, with or without notice.

Login and Member Responsibility

If you purchase a "single designer" license your login may only be used by one person – a single login to BankersHub's INXPO environment by multiple people is not permitted. Each viewing content or utilizing other services within INXPO needs a unique user account.

- The Passport Member purchasing the subscription may or may not be the designated primary owner of the service. If not, it will be the Member's responsibility to notify BankersHub of the name/email of that contact person.
- Passport Members are granted access to BankersHub's INXPO environment for playback viewing, social networking, and other services. Only 1 (one) sign in is granted with a Passport Membership. Additional logins, however, may be purchased for a nominal price. Please refer to the BankersHub website for additional information.
- Upon occasion, Passport Members may extend up to 2 (two) additional log-ins for live events at no additional cost. These events are hosted outside of the INXPO environment so attendees will not have access to the other benefits granted the Passport Member.
- Passport playback links are available to the Passport Member in INXPO, as well as in the BankersHub® Sproutvideo server. Sproutvideo playbacks and MP4 downloads are accessible to other employees of the corporation or institution in which the Member is employed at time of purchase.
- Your access and use of events and materials is at your sole risk. Passport events, materials and services are provided on an "as is" and "as available" basis. BankersHub® makes no claims, guarantees or warranties to the accuracy of any individual events, statements or content. All content and materials are owned and managed by the individual presenters and subject matter experts.
- You agree to immediately notify Bstuff LLC at Service@BankersHub.com of any unauthorized use of your password or account, or any other breach of security.
- You may not use Passport Membership for any illegal or unauthorized purpose. You must not, in the use of the Service, violate any laws in your jurisdiction (including but not limited to copyright laws, trademark laws, patent laws, other intellectual property or industrial property laws, privacy laws, data export laws, and laws regarding libel and defamation).

You agree to indemnify, defend, and hold harmless Bstuff LLC, its officers, directors, employees, agents, licensors and suppliers (collectively the "Service Providers") from and against all losses, expenses, damages and costs, including reasonable attorneys' fees, resulting from any violation of these terms and conditions or any activity related to your account (including negligent or wrongful conduct) by you or any other person accessing the site using your Internet account.

Changes to Service and Pricing

Although Bstuff LLC endeavors to maintain its prices indefinitely once a subscriber becomes a Passport Member, Bstuff LLC reserves the right at any time, and from time to time to modify or discontinue, temporarily or permanently, the Service (or any part thereof) with or without notice. Access to and use of these materials are granted to you through your Passport Membership. Bstuff LLC grants you a personal, non-transferable and non-exclusive right and license to use the assets in the Playback Environment; provided that you do not (and do not allow any third party to) create, revise or otherwise use these materials that you sell and/or distribute for free.

On occasion, some speakers may limit or restrict playbacks, presentations or other materials. BankersHub® takes no responsibility for such restrictions or limitations and is not responsible for or warranty against any costs, impacts or losses resulting from such omissions.

General Conditions for Passport Membership Terms of Service

Entire Agreement. The Terms of Service (including any policies, guidelines or amendments that may be presented to your form time to time) constitute the entire agreement between you and Bstuff LLC and govern your use of the Service, superseding any prior agreements between you and Bstuff LLC for the use of the Service. You also may be subject to additional terms and conditions that may apply when you use or purchase certain other services, third-party content or third-party software.

Choice of Law and Forum. The Terms of Service and the relationship between you and Bstuff LLC shall be governed by the laws of the State of Wisconsin without regard to its conflict of law provisions. You and Bstuff LLC agree to submit to the personal and exclusive jurisdiction of the courts located within or nearest to Dane County, Wisconsin.

Waiver and Severability of Terms. The failure of Bstuff LLC to exercise or enforce any right or provision of the Terms of Service shall not constitute a waiver of such right or provision. If any provision of the Terms of Service is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of the Terms of Service remain in full force and effect.

Statute of Limitations. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of the Service or the Terms of Service must be filed within one (1) year after such claim or cause of action arose or be forever barred.

No Third Party Beneficiaries. You agree that, except as otherwise expressly provided in these Terms of Service, there shall be no third party beneficiaries to the Terms of Service.

Notices. You agree that Bstuff LLC may provide you with notices, including those regarding changes to the Terms of Service, by email, regular mail, or postings on the Service. Your notices to Bstuff LLC must be sent by an email to Service@BankersHub.com, which is acknowledged by a reply from Bstuff LLC, or by a courier service which provides delivery confirmation.

Assignment. Bstuff LLC may assign this contract, in whole or in part, at any time with or without notice to you. You may not assign this contract, or any part of it, to any other party. Any attempt by you to do so is void. Instead, you may cancel your access to Passport at any time. The other party may then establish a Passport Membership and enter into a contract with Bstuff LLC.
